ITEM 5. Technical & NTC update

a. **Tyres for 2017**. Flyer from Giti received concerning a new Vee tyre. Hoosier sales not too good and member complaints regarding cost of Hoosiers. Poor wear in Vic but good wear in WA and QLD. Proposal to run a tyre assessment in mid 2016 so options can be made for 2017 or 2018. Discussion of road tyre usage – thoughts about accidents due lack of grip and excess wear ona race track – most Reps did not like the idea.

Action item 159. NTC to provide a plan to test and compare Race or R spec tyres in mid 2016.

- b. **Rain Lights** NTC in discussion with CAMS regarding new rules for FIA approved lights.
- c. **CNC Heads** next month
- d. **NTC direction for 2016** tyres. Clarifying ambiguous rules. 5 year plan.
- e. **CAMS Manual proposed changes**. Several changes were proposed by the NTC but due to new members of the committee not receiving a previous email it was decided to allow time for BOM member to review the changes and decide on a way forward a the next meeting. Items include 2.4.2 Disc Brakes, definition of a one piece assembly, a clarification on the removal of front shock towers, the removal of cooling ducts, and the machining of crankshafts
- f. Valve throat cuts

During 2015 the National Technical Committee (NTC) instigated a change to the valve seat angles allowable for Formula Vee Competition. The change that CAMS was requested to make was:

Original wording "Throat cut shall 75°" was revised to Throat cut shall be 60° to 75°. This has been rescinded.

Proposed CAMS Manual changes (in red)

2.6 ENGINE:

- (xi) Cylinder Heads:
- (b) Replacement of valve seat inserts is permitted. A maximum of three (3) cuts is permitted on each valve seat insert. For 1200cc, all valve seat cuts must be confined to the insert. For 1600cc, the maximum outside diameter of the top cut is 38.5mm for inlet and 35.5mm exhaust (i.e. the maximum allowable Valve insert). The Top Cut, may extend into the combustion chamber of head. The angle of the top cut is free.

The throat diameter may be enlarged. Throat cut shall be 75° Throat cut shall be 60° to 75°. Valve seat angle shall be 45° ± 1.5 °.

Rational:

Tolerance the Throat Cut Angle was originally intended to reduce the cost to competitors allowing 60° Valve seat cutters to be used on the Throat Cut as they are readily available. Feedback from a broad spectrum of competitors post the change being introduced is that the change will result in the



majority of the field to 60° Throat Cut angles, driving up cost to competitors and negating any potential savings. Request is to reverse the change.

Cylinder head refund request from Chris Scoble

Dear FVAA,

In October 2013 I purchased a set of new FVAA cylinder heads through the association. They were delivered to David Cutts by Leigh Porter.

Since then, both David Cutts and Michael Kinsella have assessed and flow tested the cylinder heads and found them to be not up to par with other average competition heads.

One of the heads has a hole in the rocker box which renders it unserviceable, as under the FVAA rules it cannot be repaired for use in FV competition.

As I purchased these in good faith from the association, and having considered the advice from the abovementioned experts, I would like to return these cylinder heads for a full refund.

Should you wish to inspect them, they are still in the care of David Cutts.

I look forward to hearing back from you.
