Item 1 - Introductions and Action Item Review

SW welcomed the Directors and noted apologies. See Action Item table below for details of review of previous Action Items.

Item 2 - Acceptance of Previous Minutes

The draft minutes of the previous meeting held on 24th April, 2009 were passed as a true and accurate record of the meeting (SH/GH).

Item 3 - Finance Report

BoM Reviewed April Accounts

DB confirmed that only one set of AR's have been received by FVAWA, where as invoice issued from FVAA was for three sets.

- DB to confirm if single set of AR's have been paid for
- If not then LP to reconcile via credit to FVAWA.
- SW to investigate why invoice states three sets and only one set received.

Outstanding invoices at April End of Month:

- \$121 SA
- \$990 QLD
- \$2190 WA (refer item above re AR tyres)

\$2k each received from both Hoosier and Dunlop to cover Tyre Testing costs.

- \$3200 required for track hire
- \$800 remaining for fuel.
- Excess to be remain in FVAA accounts
 - o GH to obtain receipt for fuel and any other incidentals required on Tyre Test day.

MM requested that FVAA invoice individual State Associations for rounds of the Shannons Nationals Series run in 2008 that delivered a loss.

- General discussion occurred re the requirement State associations were required to meet once they committees to running a Shannons National Meet.
- ML advised that Minutes of the 9th meeting of FVAA stated that FVAA would underwrite up to \$3000 loss.
- ML proposed that since the only round FVAA could invoice a State Association for was
 the NSW round for \$200 (\$3200 loss), the benefits were outweighed by the negatives of
 doing so.
 - o Seconded by DB
 - o Motion carried.

ML raised question of a \$13k invoice that FVAA paid on behalf of FVNSW.

- Leigh Porter confirmed that FVANSW accounts have recently been audited for years 2000 to current and he has no knowledge of issue.
- SW to contact Rick Kirkness to confirm if transaction occurred and under what conditions.
 - Note issue has been discussed outside of BoM meeting and is anticipated to be formally closed at next BoM meeting

Item 4 - Tyres

Tyre Test scheduled for 19th May at Oran Park

- Two sets of Dunlop's and Hoosier's to be available.
 - One set of each brand to have approx 300km race condition driving performed prior to day of test. Intention is to simulate three race meetings
 - One set of each to be in as received condition.
- Method intended to be used on day of test was discussed and agreed to be acceptable.
 - o GH to publish on FVAA website for general review.
- Questionnaire to be completed and sent to tyre suppliers.
 - o ML to draft and get buyin from BoM.
- Formula Ford Tyre contract to be used as basis for FVAA Tyre contract.
 - o SW to contact Formula Ford to obtain copy of contract.
 - BoM members to canvas members to determine if ant members are suitably qualified to review proposed contract and provide advice to FVAA. (Will need to be clearly identified if it is general advice or Professional opinion that is being provided by any volunteers from State Associations)

Item 5 – Shannons National Series

Tasmanian round of Shannons National Series assumed to be off but requires confirmation.

ML proposed that "Any Shannons National rounds that Formula Vee accepts and invitation to, other than what FVAA has already committed to underwriting, are to be underwritten by the State Association that the round is to be held in and not FVAA."

- Motion accepted.

Winton Round

- Discussion and agreement that for the Winton round, an Eligibility Officer is to be sort from Victoria to avoid travel expenses.
 - o MM and GH to organise.
- Entry Form required from Rob K, SW to contact and organise
- Once received will be posted on FVAA website.
- Entry Funds to be deposited directly into FVAA account
 - o LP to provide BoM with monthly update
- FVAA BoM to be included on distribution of emails dealing with Winton Round organization to ensure it is informed of developments.

Item 6 - Formula Vee Nationals - Tas

- Good progress on organization
- PW to provide update at next BoM meeting.

Item - Technical Update

No meeting of NTC in March owing to difficulties with moving to Skype.
